IN exercise of the powers under clause (c) sub-section (2) of section 46 read with sub-section (3) of the said section and section 2 of the Police Act, 1861 (Act no. 5 of 1861) and all other powers enabling him in this behalf, the Governor is pleased to make the following rules with a view to amending the Uttar Pradesh Civil Police Constable and Head Constable Service Rules, 2008.

THE UTTAR PRADESH POLICE CONSTABLE AND HEAD
CONSTABLE SERVICE (SIXTH AMENDMENT) RULES, 2014

Short title and
commencement

1. (1) These rules may be called the Uttar Pradesh Police Constable and Head Constable Service (Sixth Amendment) Rules, 2014.

(2) They shall come into force with effect from the date of their publication in the Gazette.

Amendment of
rule 5

2. In the Uttar Pradesh Police Constable and Head Constable Service Rules, 2008 hereinafter referred as the said rules in rule 5 for sub rule (2) set out in Column I below the sub rule as set out in Column II shall be *substituted*, namely :-

COLUMN-I

Existing sub rule

(2) Head Constable-The recruitment of the 50 percent of vacancies of Head Constable shall be made by promotion through a departmental examination held amongst the eligible constables and the recruitment of 50 percent of the vacancies shall be made by promotion on the basis of seniority subject to rejection of unfit.

COLUMN-II

Sub rule as hereby substituted

(2) Head Constable-The recruitment of the 100 percent vacancies of Head constable shall be made by promotion amongst the eligible Constables made on the basis of seniority subject to rejection of unfit.

Amendment of
rule 17

3. In the said rules in rule 17, for clause (b) set out in column I below the clause as set out in Column II shall be *substituted*, namely :-

COLUMN-I

Existing Clause

(b) Head Constable promoted on ex-cadre posts meeting the requirement will also be eligible for promotion to the post of Head Constable under sub-clause (a)

The detailed procedure for promotion to the post of Head Constables through seniority subject to rejection of unfit is given in Appendix-2(2).

COLUMN-II

Clause as hereby substituted

(b) Those constables who have been promoted out of turn and are working as Head Constables Civil Police shall also be eligible for promotion to the post of head constable civil police as per their seniority in their substantive rank.
