FOR DESIGNING & IMPLEMENTATION OF
“ONE TIME REGISTRATION” (OTR) PROCESS FOR RECRUITMENT
ON VARIOUS POSTS IN U.P. POLICE

The UPPRPB is a Board constituted by Govt. of UP for carrying out all recruitment and promotion processes for subordinate police officers. The Board is committed to the use of effective procedures with integrity and reliability for ensuring maximum transparency with innovative use of technology, timely dissemination of information and a prompt grievance redressal system.

The Board invites EOI (Expression of Interest) from reputed companies who have successfully conducted recruitment related activities & provided software services & solutions in Union Public Service Commission, State Public Service Commission, Engineering, Medical or management courses, public sector enterprises and police organisations.

SCOPE OF WORK – ONE TIME REGISTRATION (OTR)

1. Design, develop and deploy a secured web portal (Certified by CERT-IN) for UPPRPB by providing a One Time Registration (OTR) platform for all candidates who are interested to apply for the various posts published by UPPRB.
2. The developed and deployed software must be supported by interested agency/company for a period of 2 years. The agency/company must deploy a dedicated team in UPPRPB premises for a period of 2 years.
3. The OTR Platform must have Digi-locker integration to authenticate every candidate for registering in OTR platform.

4. Upon candidate's authentication the OTR platform must be able to access documents authorised by the candidate like educational, caste, domicile certificates etc.
5. The OTR platform must be able to encrypt all the information received by the candidate and the Digi-Locker and store all the information in an encrypted format only.
6. The OTR platform must be integrated with E-Aadhar KYC. The Department/Board will facilitate as SUB-AUA to get the API as well as necessary approvals from UIDAI.
7. OTR platform must have all major banks link (Payment Gateway Integration) for the candidates to pay fees for applying to any post published by UPPRPB.
8. The OTR platform must be able to send bulk SMS/Email/ WhatsApp to the candidates.
9. The OTR platform must provide a mobile responsive application for the candidates to complete their One Time Registration and to apply for various posts published by UPPRPB including payment gateway integration. The mobile application shall display information to all candidates showing their status and results of all stages etc.,
10. Establish a help/grievance redressal centre by Phone/Email for helping the candidates in registering OTR and applying for various posts published by UPPRPB.

QUALIFYING CRITERIA

1. Having a secure server at two different seismic zones in India.
2. Company should be registered in India under Companies Act 1956 or Companies Act 2013 as a company providing I.T. solutions for the last 5 financial years ending 31.03.2023. No Joint Venture or Consortium is allowed.
3. The Bidder shall have ISO 9000:2008 or higher certificate but PSUs are exempted from these certifications.




4. The Bidder must have an average annual turnover of not less than INR 2 Crores for each of the last three financial years ending 31st March 2023.
5. The Bidder (IT Service provider) must have a proven track record of providing a successful Turnkey solution for at least three (03) IT-projects, during last 3 financial years where each work must be minimum of 20 lakhs billable (incl of GST).
6. Bidder should not have been blacklisted by any State Government OR PSU and a Self-Declaration to that effect from the bidder is required.

The interested companies to perform as enumerated above should apply to the Board their expression of interest (EOI) by 16/7/23, 2023 to sampark@uppbbp.gov.in.

The information must also be sent in hardcopy to the undersigned. If you have any query, you may communicate through email to sampark@uppbbp.gov.in before the last date of the submission of the EOI.

In addition to the above, it is also informed that companies submitting E.O.I. and found eligible as per EOI conditions will be communicated separately by email about date and time for subsequent presentation in the Board.
